CUSTOM LINK

BANNER AD

Adventist Contact, Inc. will pay Associate \$0.25 per **page** per quarter (90 days) for each page on which the Adventist Contact, Inc. banner is displayed (subject to approval by Adventist Contact, Inc.; maximum of \$25.00 per quarter). This banner ad will activate the custom link described above.
